TRAVEL ASSUMPTION OF RISK & RELEASE OF LIABILITY

This is a release of your legal rights. Please read and understand it before signing.

This is a legally binding Release, Waiver, Discharge and Covenant Not to Sue (collectively, "Release"), made voluntarily by me, the undersigned Releasor, on my own behalf, and on behalf of my heirs, executors, administrators, legal representatives and assigns (hereinafter collectively, "Releasor," "I" or "me", which terms shall also include Releasor's parents or guardian, if Releasor is under 18 years of age) to the Great Game Travel Company – Afghanistan, LLC (hereinafter, "Great Game Travel").

ACKNOWLEDGEMENT OF RISK: First, I acknowledge that there are serious risks associated with Great Game Travel tours (hereinafter, "Tours" or "Touring") in Afghanistan and that Great Game Travel cannot control these risks. I understand that these risks include exposure to serious health and safety hazards such as: transportation accidents; storms, floods, earthquakes, and other natural disasters; infectious diseases, inadequate medical care, remote access to medical treatment; armed insurrections, and terrorist activities. I further acknowledge that these hazards may result in my temporary or permanent disability and/or death.

Second, I further understand that Tours include wilderness treks across dangerous and unpredictable terrain. I acknowledge that these treks are inherently dangerous and contain hazards including: land mines, falling rocks, tremendous physical exertion, sunburn, high altitude sickness, heatstroke, and other risks associated with high altitude extreme trekking. I acknowledge that these hazards may result in my temporary or permanent disability and/or death.

Third, I agree to assume and take on myself all of the risks and responsibilities in any way arising from or associated with Touring in Afghanistan, and I release Great Game Travel and all of its affiliates, divisions, departments and other units, committees and groups, and its and their respective governing boards, officers, directors, principals, trustees, legal representatives, members, owners, employees, agents, administrators, assigns, and contractors (collectively "Releasees"), from any and all claims, demands, suits, judgments, damages, actions and liabilities of every name and nature whatsoever, whenever occurring, whether known or unknown, contingent or fixed, at law or in equity, that I may suffer at any time arising from or in connection with Touring in Afghanistan, including any injury or harm to me, my death, or damage to my property (collectively "Liabilities"), and I agree to defend, indemnify, and hold Releasees harmless from and against any and all Liabilities.

HEALTH AND MEDICAL CARE: First, I declare that I am in good health, have no physical conditions that affect my ability to travel and/or participate in any of the activities involved in travel in Afghanistan, and have not been advised otherwise by a medical practitioner. In this regard, I have completed an Emergency Contact & Medical Information Form.

Second, I agree that Great Game Travel is not obligated to attend to any of my medical or medication needs, and I assume all risk and responsibility therefore. However, in case I am incapacitated, I grant to Great Game Travel full authority to take whatever action it deems is warranted under the circumstances regarding my health or safety in connection with my travel in Afghanistan, including the providing of any emergency first aid, medication, medical treatment, or surgery if surgery is deemed necessary by medical personnel. This authority will permit Great Game Travel, at its discretion, to place

me, at my own expense, in a local hospital for medical services and treatment, or, if no hospital is available, to place me in the hands of a local medical doctor for treatment. Great Game Travel is further authorized to arrange a medical evacuation for me from Afghanistan, at my own expense, for medical treatment if, in consultation with local medical authorities, this is deemed to be necessary. I further agree to reimburse Great Game Travel for any expenses incurred on my behalf for medical treatment and/or evacuation. I also authorize medical personnel to execute any documents relating to medical attention and to act on my behalf, if I am unable to do so.

Third, I release the Releasees from all liability for any bodily injury or damage I sustain as a result of any medical care that I receive resulting from my Tour in Afghanistan, as well as any medical treatment decision or recommendation made on my behalf by an employee or agent of Great Game Travel. I agree to pay all expenses relating thereto and release Releasees from liability for any actions.

This Waiver is a legally binding agreement and will be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. Any provisions found to be void or unenforceable shall not affect the validity or enforceability of any other provisions.

I have read this entire Release. I fully understand the entire Release and acknowledge that I have had the opportunity to review this Release with an attorney of my choosing if I so desire, and I agree to be legally bound by the Release. I understand that by signing below, I have given up substantial rights. I have voluntarily signed this release.
